**e-Textbook:** Calculus, Early Transcendentals (9<sup>th</sup> ed.) by James Stewart, available through WebAssign (see below).

WebAssign: Students taking this course are required to enroll in WebAssign, an online instructional system providing access to the e-textbook, online homework assignments, and other resources. To sign up visit webassign.com and use the class key provided to create your account.

**Course Content:** Differential and integral calculus of real-valued and vector-valued functions of several variables.

**Learning Outcomes:** This course fulfills the Quantitative Reasoning requirement of Trinity's Pathways Curriculum. Students who successfully complete this course will demonstrate the ability to: formulate and solve problems in a mathematical framework, communicate their results, and describe the significance and limitations of the quantitative approach.

**Homework:** Homework assignments will be posted to WebAssign following each lecture and will consist of reading and problem solving. It is highly recommended that you complete the assigned reading before attempting to solve any problems.

All homework is to be completed prior to the beginning of the lecture following when it was assigned. Late homework may not be accepted and will be penalized as I see fit.

Collaboration on homework assignments is permitted and encouraged, and you are free to consult any individual or source that you find helpful. However, simply copying the work of another is unacceptable. Attempting to pass off the work of others (regardless of the source) as your own will be considered a violation of the honor code.

**Exams:** There will be three midterm exams during the semester as well as a cumulative final exam. The dates for the exams are as follows:

First Midterm Exam	February 24
Second Midterm Exam	March 31
Third Midterm Exam	May 5
Final Exam	May 18

If you have a legitimate conflict with these exam times, please contact me as soon as possible. Please do not wait until shortly before the exam. Be aware that the final exam will not be given early.

**Use of Previous Exams:** Students are permitted to obtain copies of exams given in previous semesters. However, these exams should not be used to judge the content or difficulty of the exams that will be given in this course.

**Grades:** Your overall score in the course will be based upon your scores on the homework, midterm exams, and the final exam. Each of these will be weighted as follows:

Homework	1/6
Midterm Exams (3)	1/6 (each)
Final Exam	1/3

So you can gauge your performance throughout the semester, a score distribution will be posted online following each exam.

Attendance: Attendance is highly encouraged but is not mandatory. Roll will not be taken, but excessive absences should be explained to me. Lectures will be recorded and posted to T-Learn daily, and any student who misses class is encouraged to use these recordings to get caught up. Lecture recordings can also serve as a valuable resource for reviewing course material.

Due to the ongoing pandemic, I understand that many students will fall ill this semester. If you find yourself falling behind in your coursework due to a serious illness, please let me know as soon as possible so that we can decide on alternate due dates for homework and/or exams, if necessary. In particular, any student who is required to quarantine or isolate because of COVID-19 should contact me immediately so that we can determine the optimal means of attending class virtually.

This semester the pandemic is certain to make all of our lives much more difficult than usual. I would like to shoulder as much of that burden for you as I can!

**Calculators:** Homework problems may occasionally require the use of a calculator, and you should feel free to use a calculator while completing homework assignments in general. The use of calculators will be permitted during exams, but is not required.

**Electronic Recording of Classroom Instruction:** Please be aware that all classroom instruction, including student participation in classroom activities, is subject to recording and dissemination on the Universitys secure course management system (T-Learn). The recordings will be made available only to students enrolled in the course to facilitate online learning and review. Students are expressly prohibited from capturing or copying classroom recordings by any means; violations will be subject to disciplinary action. Instructors who wish to use a recording outside of class must obtain the written consent of any students who are personally identifiable in the recording.
