**Course Content:** Elementary theory of differentiation and integration of functions of a single variable, with applications.

**Learning Outcomes:** This course fulfills the Quantitative Reasoning requirement of Trinity's Pathways Curriculum. Students who successfully complete this course will demonstrate the ability to: formulate and solve problems in a mathematical framework, communicate their results, and describe the significance and limitations of the quantitative approach.

**Assignments:** Homework assignments will be posted to WebAssign following each lecture and will consist of reading and problem solving. It is highly recommended that you complete the assigned reading before attempting to solve any problems.

All homework is to be completed prior to the beginning of the lecture following when it was assigned. Late homework may not be accepted and will be penalized as I see fit.

Collaboration on homework assignments is permitted and encouraged, and you are free to consult any individual or source that you find helpful. However, simply copying the work of another is unacceptable. Attempting to pass off the work of others (regardless of the source) as your own will be considered a violation of the honor code.

**Exams:** There will be three midterm exams during the semester as well as a cumulative final exam. The dates for the exams are as follows:

<b>First Midterm Exam</b>	February 17	7–9pm
<b>Second Midterm Exam</b>	March 26	7–9pm
<b>Third Midterm Exam</b>	April 28	7–9pm
<b>Final Exam</b>	May 12	8:30–11:30am (Section 1) 12:00–3:00pm (Section 2)

If you have a legitimate conflict with these exam times, please contact me as soon as possible. Please do not wait until shortly before the exam. Be aware that the final exam will not be given early.

**Use of Previous Exams:** Students are permitted to obtain copies of exams given in previous semesters. However, these exams should not be used to judge the content or difficulty of the exams that will be given in this course.

**Grades:** Your overall score in the course will be based upon your scores on the homework, midterm exams, and the final exam. Each of these will be weighted as follows:

<b>Homework</b>	15 %
<b>Midterm Exams (3)</b>	20 % (each)
<b>Final Exam</b>	25 %

**Attendance:** Attendance is highly encouraged but is not mandatory. Roll will not be taken, but excessive absences should be explained to me.

**Calculators:** Homework problems may occasionally require the use of a calculator, and you should feel free to use a calculator while completing homework assignments in general. The use of calculators will be permitted during exams, but is not required.

**Use of ChatGPT or Other Generative AI:** All assignments submitted for this course should reflect your own thinking and work. Any use of generative AI, such as but not limited to Chat GPT, will be considered “unauthorized assistance” and a violation of academic integrity and of the Trinity University Academic Integrity (Honor Code) discussed below.
